The meeting was opened with a salute to the flag.

Public Comment:

Brandy Downing, Highview Drive, asked who prepared the 2015 budget and whether it was accurate. She was directed to file a Right-to-Know Request for any information she desired from the township.

Shirley Sallmen, Old Princeton Road, asked for an explanation as to letting William Phillips go because of costing the township too much. Mr. Riley said the department is costing too much money. Mr. Riley asked Mrs. Sallmen if she saw anyone from the police department in the room supporting Mr. Phillips. Mrs. Sallmen asked if she could go over to the police department and check if anyone was there. Mrs. Sallmen left and returned and said there were three in uniform and they didn't want to comment. Officer Darrin Cwynar then came into the room and said Mrs. Sallmen misquoted what was said. Officer Cwynar said, according to department and township policy, they are not permitted to speak about personnel issues, not meaning that in a positive or negative way.

Kimberly Booher, Gardner Center Road, asked where the funds from the sewer sale are. Mr. Burick said they are not part of the budget and that the funds are in PLIGIT, a state account, reserved for expenses, and they do not intend to spend the money immediately. Mr. Riley explained that the township pays approximately \$198,000 per year on a \$2 million loan taken out by previous supervisors.

Bill Cunningham, Hazen Street, said if they do not retain Bill Phillips, next year we need to get all new supervisors.

John Downing, IV, Highview Drive, said he was told by six people that when Sherry (sic.) is gone, Mr. Riley's daughter will take her place. It was clarified that he meant Mary Gay, and Mr. Riley said no, that is not true.

Angel Tyler-Blackwell, Old Princeton Road, asked where the money went that was used for Mr. Phillips' salary previously. Mr. Burick explained that expenses go up, and that they are going to purchase a new police vehicle because they need a new police vehicle.

Debbie Grafton, Melody Lane Extension, asked why they could not use the sewer sale money for his salary, and questioned what else was cut. Mr. Riley said the budget was one page in the past and now it is several. Mrs. Grafton questioned where the money was from the canine fund. Mr. Burick said it is in the bank and will be staying there.

Brenda Phillips, Highview Drive, described the things Bill Phillips does for the police department for which he receives no pay, and how he has saved the township money by doing things himself.

Carole Montgomery, Dean Drive, asked why not raise taxes.

William Cheslock, Old Princeton Road, asked Mr. Burick if he owns property in the township and/or other townships and said he has been told he uses his father's garage as his mailing address. Mr. Burick directed Mr. Cheslock to ask Mary Jane Cousins, Shenango Township Tax Collector, who was sitting next to him, if he (Mr. Burick) paid his taxes last week, to which Mrs. Cousins responded yes, he did pay his taxes last week.

Patsy Sheldone, Brookshire Drive, asked who would be in charge if Mr. Phillips is not there, and would there be an increase in that person's pay. Mr. Riley said there would be an officer in charge, and as of this time there would be no increase in the pay.

Brandon Rishel, Savannah-Gardner Road, said there are major issues in the township and people need to be here more often. The township owes more money than we have. He has numerous firefighters who volunteer their time and put their lives on the line all the time. He suggested people put their name on the ballot if they feel things are not right.
