Sergeant Darrin Cwynar, Officer-in-Charge, gave the monthly Police Department report. Sergeant Cwynar also reported that the police department received drug forfeiture money which enabled the department to purchase five new laptop computers for the police cars; two more cash seizures to purchase equipment for the police cars; and the police are working with the school to go in for career services for the students to replace the ride-along program. The department also has an officer going to the second and third round of arson investigation school, at no cost to the township except for lodging.

Public Comment:

Bill Cheslock, Old Princeton Road, spoke about how the township should get with the school about looking into the purchase of the former YDC facility. Mr. Riley informed Mr. Cheslock the township has nothing to do with it, and he should approach the school with his suggestions.

Brenda Phillips, Highview Drive, asked if Justin Data, the EMA Coordinator, would be able to come to a future meeting and speak to township residents. Mr. Burick said the supervisors could ask him. Mrs. Phillips asked if a township employee is permitted to leave the township for personal purposes while

working on township time. She said the employee is Mike Lynch, the date is January 23, 2016, the time was 12:15 p.m., and the vehicle was parked at Arby's in Union Township. Sergeant Cwynar left to see if he could get an answer for her, but was unable. Mr. Riley said they will get an answer for her.

Bill Phillips, Highview Drive, questioned the Township's ISO rating. Mr. Burick said he believed he had it in his office, but did not know what it was off the top of his head. Mr. Riley said they will sit down with Dave Rishel and Brandon Rishel.
