

Regular Monthly Meeting
July 14, 2016

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, July 14, 2016, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Russell Riley, Albert Burick, III, and Frank Augustine present.

The meeting was called to order and opened with a salute to the flag.

Motion by Mr. Riley second by Mr. Burick to approve the minutes of the Special Meeting of June 23, 2016, regarding the Summer Paving Bid Opening. Mr. Augustine abstained. Motion carried.

Public Comment:

Shirley Sallmen, Old Princeton Road, said she does not want a Methadone clinic in the township. Ms. Sallmen asked when Old Princeton Road will be paved. Mr. Burick said August 15.

Dave Brooks, Douglas Drive, asked how long it will take to repair the culvert on Union Valley Road. Mr. Rishel said they plan on closing it for the second project for five weeks, beginning on August 25. Mr. Brooks asked about any more money coming from Brian Tanner. Solicitor Perrotta explained that the Township received \$400,000.00 from the bonding company, but the criminal restitution is handled by the District Attorney's office. Mr. Brooks asked if the computers are back yet. Mr. Burick said they are not.

Marsha Presnar, Circle Drive, asked what the burning hours are in the township. Mr. Rishel said agricultural areas are exempt from burning hours and only residential areas have to abide by the burning laws. Ms. Presnar said she is against a Methadone clinic in the township, and said Lawrence Village Plaza is a disaster.

Barbara Thompson, Boyd School Road, asked what the markings are on Old Pittsburgh Road. Mr. Burick said they are putting a new gas main in. Ms. Thompson said she is against a Methadone clinic in the township, and asked if the residents would have a right to appeal the decision if it should be approved by the Zoning Hearing Board. Solicitor Perrotta explained the procedure.

Amanda Smith, Crowe Street, said she is not able to pay for the mandated garbage service, and produced a citation she received because she is not signed up for service. Mr. Burick said he would look into it, but could not make any promises.

Dorothy Fracul, Highview Drive, asked when Highview Drive will get done. Mr. Riley said it would be September.

Debby Balagna, Basilone Drive, asked if there was a way to get people to put their trash containers back up at their house. Solicitor Perrotta said there is an ordinance prepared, but there are residents opposed to having a regulation, then asked Ms. Balagna if she would be an advocate for the ordinance, to which she responded she would be.

Robert Uzman, Fields Drive, read a letter requesting a ban on exploding targets in the township. Mr. Burick said it is on the agenda for the meeting tonight.

Joe Monsour, Hoover Road, said his mailbox was taken down because of work being done on Old Butler Road and then it was put back up by Bill Albertini, but said if you lean on it, it will fall.
