Zoning Map Amendment Hearing December 4, 2014

Mr. Perrotta asked Mr. Yokel if he had the deed to the property with him. Mr. Yokel said he did not, but he would provide it.

Mr. Perrotta explained the procedure for rezoning property.

Gregory W. Zeitler, New Butler Road, said he is satisfied with Mr. Yokel's answer to Mr. Riley as far as his goals for this property and said he has no problem with the change.

Michael Mangiarelli, Wilmington Road, was asked if he had anything to say, and he responded negatively.

Mr. Perrotta said the hearing for the property was properly advertised in the New Castle News.

(There was no comment from the three supervisors.)

Mr. Burick said this was the southern side of the 422 corridor and some of the surrounding businesses were McKesson, New Castle Truck and Trailer, and Apollo Storage.

Mr. Perrotta said he would hold the record open for the exhibits and findings of fact and conclusions of law.
