Public Comment:

Mr. Joe Monsour, Hoover Road, asked if anything could be done about the storm water issue on Old Butler Road, due to the storm water is coming from an ordained road? Mr. Riley suggested a speed bump to possibly divert the water to the catch basin and will look into it.

Mrs. Doak asked if anything was locating in Lawrence Village Plaza, the supervisors stated that Bottom Dollar was contacted.

Mr. Herman stated that the township is looking to having a cleanup day, details to follow.
