AN ORDINANCE

CONDEMNING AND TAKING CERTAIN LANDS IN SHENANGO TOWNSHIP,
LAWRENCE COUNTY, PENNSYLVANIA TO PROVIDE FOR STORAGE, WAREHOUSES
AND OFFICES AND FOR THE ERECTION OF BUILDINGS NECESSARY FOR THE
MAINTENANCE AND STORAGE OF MATERIALS AND EQUIPMENT USED BY THE
TOWNSHIP SUPERVISORS IN THE MAINTENANCE OF ROADS AND OTHER TOWNSHIP PROPERTY AND ANY OTHER USE AUTHORIZED BY THE LAWS OF THE
COMMONWEALTH OF PENNSYLVANIA, WHICH LANDS ARE THE PROPERTY OF THE
LATTAVO CONSTRUCTION COMPANY, INC.; PROVIDING FOR THE ASSESSMENT
OF COSTS AND DAMAGES FOR THE TAKING AND CONDEMNING OF THE SAME,
FOR THE SETTLEMENT OF SUCH COSTS AND DAMAGES WHERE POSSIBLE AND
FOR THE PAYMENT THEREOF, AND FOR THE COMPROMISE AND SETTLEMENT
OF CLAIMS FOR DAMAGES, WHERE SUCH COMPROMISE AND SETTLEMENT CAN
BE MADE.

WHEREAS, For a long time the Township of Shenango has had need for a parcel of land so situated that it may be used for storage and warehouses and for the erection of buildings necessary for the maintenance and storage of materials and equipment, as well as other uses pertaining to the efficient operation of the township.

SECTION 1. NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE SUPERVISORS OF THE TOWNSHIP OF SHENANGO, LAWRENCE COUNTY, PENNSYLVANIA, THAT The following described property in Shenango Township, Lawrence County, Pennsylvania is hereby condemned and taken by the said township, to-wit:

Beginning at a point on the southwest line of willowhurst Circle which point is eighty (80) feet east of where

the said southwest line of Willowhurst Circle intersects the center line of a public road known as the Joyce Road, thence along the said southwest line of Willowhurst Circle South 35° 00' East, a distance of twenty (20) feet to a point; thence South 55° 00' West, a distance of one hundred eighty-nine and forty-four hundredths (189.44) feet to a point; thence North 18° 42' West, a distance of twenty and eighty-four hundredths (20.84) feet to a point; thence along other lands of the Grantee, North 55° 00' East, a distance of one hundred eighty-three and six tenths (183.6) feet to a point on the southwest line of Willowhurst Circle, the place of beginning, and being part of Lots Nos. 1 and 2 in Willowhurst Manor Plan of Lots. A plot of which is of record in Recorder's Office of Lawrence County in Plot Book Vol. 12, page 13.

SECTION 2. All damages resulting from the condemnation and taking of the said lands shall be determined, assessed and paid for in the manner provided by law; provided, however, that if, at any time, the owners of any of the said lands shall agree with the Supervisors of Shenango Township on the amount of damages to be paid for such land, the same may be compromised and settled upon the execution of a deed to the Township of Shenango for such land by the owners thereof; and all damages finally assessed according to law, or compromised and settled, for the taking of the said lands, shall be paid for out of appropriations to be made and designated by the Supervisors for that purpose.
