

LEGAL NOTICE

Notice is hereby given by the Shenango Township Board of Supervisors, Lawrence County, Pennsylvania, that they have enacted the following Ordinance at their regular meeting held at the Shenango Township Supervisors' Bldg., Allegheny Avenue, Shenango Township, Lawrence County, Pennsylvania, at 8:00 P.M., on January 10, 1958.

ORDINANCE NO. 1 1958

An Ordinance regulating the construction, opening, or dedication of any road or street, or alley, or of any drainage facilities in connection therewith, for public use or travel in Shenango Township, Lawrence County, Pennsylvania, requiring the submission of plans and approval of the Supervisors; prescribing penalties for the violation of any of the provisions of this Ordinance.

The Board of Supervisors of Shenango Township, Lawrence County, Pennsylvania, hereby ordains as follows, under the authority of "The Second Class Township Code", the Act of May 1, 1933, P.L. 103 as amended, revised, consolidated, and re-enacted by the Act of July 10, 1947, P.L. 1481, as amended:

SECTION ONE: The Ordinance shall be known and may be cited as "The Shenango Township Street Planning Ordinance".

SECTION TWO: No person shall construct, open, or dedicate any road, or any drainage facilities in connection therewith, for public use or travel in Shenango Township, without first submitting

plans, in duplicate, thereof to the Shenango Township Board of Supervisors for approval.

SECTION THREE: No streets or roads shall be henceforth constructed, opened, or dedicated for public use or travel unless of a minimum width of fifty (50) feet.

SECTION FOUR: No alley shall be henceforth constructed, opened, or dedicated for public use or travel unless of a minimum width of fifteen (15) feet.

SECTION FIVE: Any plan submitted in conformity with this Ordinance must show the profiles of such road, street, or alley, and the course, structure, and capacity of any drainage facilities and method of drainage.

SECTION SIX: Any road, street, or alley henceforth constructed, opened, or dedicated for public use or travel must be in accord with the rules and regulations adopted by the Shenango Township Board of Supervisors and must conform to the construction and road building requirements now in effect by the Shenango Township Board of Supervisors.

SECTION SEVEN: The Board of Supervisors of Shenango Township may alter such plans as in their discretion they deem necessary and when said plans are approved by said Board the same shall be filed with the Secretary of the Board of Supervisors and a duplicate copy of such plans shall be recorded by the person applying for such approval in the Office of the Recorder of Deeds in and for Lawrence County, Pennsylvania.

SECTION EIGHT: Any person who shall violate any of the provisions of this Ordinance shall, upon conviction before a Justice of the Peace of this Township, be subject to pay a fine of not less than \$10.00 nor more than \$100.00 and costs of prosecution, and in default of payment of such fine and costs, shall be sentenced to imprisonment in the Lawrence County Jail for a period of not more than ten (10) days.

SECTION NINE: This Ordinance shall go into effect five (5) days after its enactment.
