

AMENDMENT TO ORDINANCE
NO. 3-1987
SHENANGO TOWNSHIP
LAWRENCE COUNTY

WHEREAS, the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania, have determined that certain amendments to the Shenango Township Ordinance No. 3-1987 are needed;

NOW, THEREFORE, be it ordained and enacted by the Supervisors of the Township of Shenango, Lawrence County, Pennsylvania;

That Item A of the Shenango Township Ordinance no. 3-1987 be and is hereby amended to read as follows:

A. A tap fee to the Shenango Township Sanitary Sewer System be charged for each connection in the following manner:

FLOW PER DAY

AMOUNT OF TAP-IN FEE

0 - 350 Gallons

\$ 600.00

351 Gallons or more

\$ 600.00 plus \$100.00 for
every 350 gallons thereafter.


For each multi-family dwelling unit a report shall be submitted with the application for a sanitary sewer tap.

All other Section of said Ordinance No. 3-1987 shall remain as previously adopted.


The invalidity of any part of this ordinance shall not affect the validity of any other part of this ordinance.


This amendment to the Shenango Township Ordinance No. 3-1987 shall become effective five (5) days after its passage or adoption.

ORDINANCE NO. 3-1987

An Ordinance imposing fees to be levied against properties benefited, improved, or accommodated by the Shenango Township Sewerage Improvements Project.

WHEREAS, Shenango Township has heretofore approved the construction by Shenango Township Municipal Authority of certain additional sewers, pumping stations, force mains and appurtenances constituting additions to the existing sewer system of the Township; and

WHEREAS, the aforesaid Authority and the Township have entered into a Contract and Lease under the terms of which the Authority has leased to the Township the aforesaid additional sewers, etc., for operation by the Township; and

WHEREAS, the Township desired to levy tap fees and front-foot assessments against those properties benefited, improved, or accommodated by aforesaid project; and

WHEREAS, Certain Rules and Regulations must be stipulated and adopted with respect to the determination of assessable front footage.. Said Rules and Regulations being attached hereto and made a part hereof, by reference.

NOW, THEREFORE, BE IT ORDAINED by the Supervisors of Shenango Township, Lawrence County, Pennsylvania, the following be enacted:

- A. That a tap fee of \$600.00 be charged for every connection made to said project.
- B. That a rate of \$14.00 per assessable front-foot be levied against all properties benefited, improved, or accommodated by the project.
- C. That the Assessment rules attached hereto are made a part hereof and approved and adopted by the Township.
- D. That the Township direct the Township solicitor to file liens against the properties assessed when payment is not made in accordance with law.

Ordained and enacted into law by the Board of Shenango Township Supervisors this 20th day of April 1987.
