

ORDINANCE NO. 4-1990
SHENANGO TOWNSHIP, LAWRENCE COUNTY
WEIGHT LIMIT & SPEED LIMIT ORDINANCE FOR
LOWER BOYD SCHOOL ROAD, UPPER BOYD SCHOOL ROAD
AND GREENHOUSE ROAD

WHEREAS, the Township of Shenango have requested and secured an Engineering and Traffic Study of the Lower Boyd School Road, the Upper Boyd School Road and the Greenhouse Road, all located within Shenango Township, Lawrence County, Pennsylvania; and

WHEREAS, said Engineering and Traffic Study as performed by the Township Engineer recommends a weight limit and posting of said roadways as follows:

Lower Boyd School Road:	15 tons
Upper Boyd School Road:	15 tons
Greenhouse Road:	15 tons

and

WHEREAS, said Engineering and Traffic Study as performed by the Township Engineer recommends a speed limit and posting of said roadways as follows:

Lower Boyd School Road:	35 MPH
Upper Boyd School Road:	35 MPH
Greenhouse Road:	35 MPH

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Shenango Township, Lawrence County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

That the Lower Boyd School Road, located in the Township of Shenango, surveyed from the intersection of Lower Boyd School Road and Snake Run Road continuing northeast for approximately 1.2 miles to the intersection of Boyd School Road, shall be posted with a weight limit of 15 tons and a speed limit of 35 MPH; and

That the Upper Boyd School Road, located in the Township of Shenango, surveyed from the Shenango-Wayne Township line to the intersection of the Old Pittsburgh Road, total distance is approximately 2 miles and is in a north-south direction, shall be posted with a weight limit of 15 tons and a speed limit of 35 MPH; and

That the Greenhouse Road, located in the Township of Shenango, surveyed from the intersection of the Lower Boyd School Road to the Shenango Wayne Township Line, approximately .4 miles in a northwesterly-southeasterly direction, shall be posted with a weight limit of 15 tons and a speed limit of 35 MPH; and

FURTHER, that said posting of these roadways shall be in accord with the recommendations and specifications of the State, as well as the Township Engineers; and

FURTHER, that vehicles exceeding the posted weight limit of 15 tons and 35 MPH shall be subject to penalties as prescribed by the Pennsylvania Vehicle Code and other applicable Pennsylvania Statutes; and

FURTHER, that the Traffic and Engineering Studies of all said roadways are attached hereto and made a part hereof.

NOW THEREFORE, be it ordained and enacted into an Ordinance by the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania, on this 13th day of September, 1990.

AMENDMENT TO
ORDINANCE NO. 5-1990
RECYCLING ORDINANCE

- - - - -

WHEREAS, the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania, have determined that certain amendments to the Shenango Township Ordinance No. 5-1990 are needed;

NOW, THEREFORE, be it ordained and enacted by the Supervisors of the Township of Shenango, Lawrence County, Pennsylvania;

That the Section 4 and Section 6 of Shenango Township Ordinance No. 5-1990 be and is hereby amended to read as follows:

Section 4. Separation of Recyclables and Leaf Waste and Placement For Collection.

Recyclable materials and leaf waste shall be kept separate from solid waste and placed by residences at the curb (or in areas designated by the municipality), for collection at such times and dates as may be hereinafter established by regulations. Commercial, municipal and institutional establishments and community activities and multi-family housing properties shall establish programs for the separation, storage and collection of recyclables and leaf waste in a manner in accordance with hereinafter established regulations.

It will be considered a misdemeanor for those persons who are found mixing waste materials with recyclable items. A fine of \$1,000 shall be imposed on those convicted of said misdemeanor.

Section 6. Collection By Unauthorized Person(s)

Licensed haulers in Shenango Township will collect the recyclable items from their customers, as well as other interested homeowners.

It shall be a violation of this Ordinance for any person(s) unauthorized by the Municipality to collect or pick up or cause to be collected or picked up any such recyclable material. Each such collection in violation hereof shall constitute a separate and distinct offense punishable as hereinafter provided.
