AMENDMENT OF ORDINANCE NO. 7 OF 2017**

AN ORDINANCE OF THE TOWNSHIP OF SHENANGO, LAWRENCE COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF MAKING VARIOUS CHANGES, CLARIFICATIONS AND AMENDMENTS TO ORDINANCE NO. 7 OF 2017, THE SHENANGO TOWNSHIP PUBLIC GATHERING ORDINANCE

WHEREAS, in the judgment of the Board of Supervisors, an amendment to the Shenango Township Public Gathering Ordinance is necessary to lessen restrictions of said Ordinance and promote certain established and lawful activities of residents and community members; and

WHEREAS, revisions in this document will appear as follows: struck out for items removed and underlined for items added; and

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania that the Shenango Township Public Gathering Ordinance No. 7 of 2017 is amended as follows:

Paragraph 3 of the Preamble is hereby amended to contain the following language:

WHEREAS, the Board of Supervisors of Shenango Township takes public notice that gatherings of people numbering more than ~~two hundred (200)~~ five hundred (500)...

Section 2. Definitions is hereby amended to contain the following language:

B. **"Public Gathering"** means all assemblies of people gathered in Shenango Township for purpose of public entertainment, amusement or recreation, reasonably anticipated to number numbering more than ~~two hundred (200)~~ five hundred (500)...

Section 7. Bond of Indemnity, Insurance is hereby amended to contain the following language:

C. The Corporate bond of indemnity or cash deposit shall be made in the following amounts:

- ~~1. Public gathering reasonably anticipated to number 200 up to 1000 persons, Thirty Thousand (\$30,000) Dollars.~~
1. Public gathering reasonably anticipated to number ~~more than 1000 but less than 2000 persons,~~ 500 up to 2000 persons, Thirty Thousand (\$30,000) Dollars.
2. Public gathering reasonably anticipated to number 2000 or more persons, Fifty Thousand (\$50,000) Dollars.

Section 15. Exemptions is hereby amended to contain the following language:

Assemblies of people gathered in Shenango Township for the following shall not be considered public gatherings under this Ordinance and shall be exempt from the rules procedures, permits and fees discussed herein:

- A. Musical, recreational, athletic and educational events conducted by or permitted by schools, local government, community or community associations or village and church festivals or fairs, or municipal corporations or events sponsored by non-profit organizations,
- B. Weddings, funerals, car-shows, golf outings and events conducted at private residences or private clubs.

The Township may require written documentation from the entity concerning the exemption.


