ORDINANCE NO. 1 of 2018

SHENANGO TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE TOWNSHIP OF SHENANGO, LAWRENCE COUNTY, PENNSYLVANIA, TO ORDAIN, ENACT, LAY OUT AND OPEN CORNELL AVENUE

WHEREAS, the property owners on the hereinafter mentioned road situate in Shenango Township, Lawrence County, Pennsylvania, have presented their petition to the Supervisors of Shenango Township, praying that the said Cornell Avenue be accepted as a public road and cared for and maintained by the Township of Shenango; and

WHEREAS, the property owners have released and forever discharged the Township of Shenango of and from all claims, demands, suits or actions for any damages which they might sustain by reason of the opening and grading of said roads.

NOW, THEREFORE, be it resolved, that the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania, hereby ordain, enact, lay out and open the hereinafter described road and the Supervisors further find that the same is necessary for the convenience of the traveling public and that the same shall become a public road or street and become a part of the highway system of the Township of Shenango, Lawrence County, Pennsylvania, subject only to the approval of the Court of Common Pleas of Lawrence County, Pennsylvania, said road being more fully described and bounded as follows:

Cornell Avenue

Beginning at a point on the centerline of Cornell Avenue a distance of 750.00 feet from the intersection with the east line of Gardner Stop Road (50 foot right of way), thence from said beginning point, North 02 degrees 05 minutes 00 seconds East, a distance of 20.00 feet to a point on the north line of Cornell Avenue; thence South 88 degrees 04 minutes 00 seconds East along the north line of Cornell Avenue, a distance of 900.00 feet to a point; thence South 02 degrees 05 minutes 00 seconds West for a distance of 40.00 feet to a point on the south line of Cornell Avenue; thence North 88 degrees 04 minutes 00 seconds West along the south line of Cornell Avenue, a distance of 900.00 feet to a point on the south line of Cornell Avenue; thence North 02 degrees 05 minutes 00 seconds East, a distance of 20.00 feet to the place of beginning.

The road right-of-way of Cornell Avenue is 40 feet as taken from the Gardner Plan of Lots recorded in the Recorder's Office of Lawrence County, Pennsylvania in Plot Book Volume 5, page 10.

SEVERABILITY.

If any section of specific provision or standard of this Ordinance is found by a court to be invalid, the decision of the court shall not affect the validity of any other section, provision, or standard of this Ordinance.

REPEALS.

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed insofar as they may be inconsistent herewith.
