AMENDMENT*

**ORDINANCE NO. 1-2006**

**SHENANGO TOWNSHIP, LAWRENCE COUNTY  
PENNSYLVANIA**

AN ORDINANCE, AMENDING ORDINANCE NO. 1-1998 ENACTED APRIL 27, 1998, TO REQUIRE THAT ONLY FULL-TIME EMPLOYEES OF SHENANGO TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA, SHALL RESIDE WITHIN AND MAINTAIN FULL-TIME DOMICILE WITHIN THE GEOGRAPHICAL LIMITS OF SHENANGO TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA, WITH THE INTENT OF EXCLUDING ANY PART-TIME EMPLOYEES FROM THIS REQUIREMENT.

BE IT ORDAINED, by the Supervisors of Shenango Township, Lawrence County, Pennsylvania, pursuant to Second Class Township Code, that the Township hereby ordains as follows:

Section 1: Shenango Township recognizes the practical limitations and difficulties for part-time employees to be required to maintain a principal residence and full-time domicile within the geographical limits of Shenango Township, Lawrence County, Pennsylvania as they may also serve other Municipalities. Nevertheless, it is the intention of the Township of Shenango to require any full-time employee to maintain his or her principal residence and full-time domicile within the geographical limits of Shenango Township, Lawrence County, Pennsylvania in order that they may be available to readily serve Shenango Township, Lawrence County, Pennsylvania and contribute to its tax base.

Section 2: Ordinance No. 1-1998, enacted April 27, 1998, is hereby amended to require that only full-time employees of Shenango Township, Lawrence County, Pennsylvania, who are employed after the effective date of Ordinance No. 1-1998, by Shenango Township, Lawrence County, Pennsylvania, shall be required to maintain his or her principal residence and full-time domicile within the geographical limits of Shenango Township, Lawrence County, Pennsylvania, with the intent of excluding any part-time employees of Shenango Township, Lawrence County, Pennsylvania, from the requirements of Ordinance No. 1-1998.

Section 3: The effective date of this Ordinance shall be five (5) days from the date of hearing and adoption of said Ordinance.
