- Agree to cooperate with the New Castle Sanitation Authority in implementing the studies, flow abatement efforts, reporting, and sewerage facilities expansion described in the "Plan & Schedule" or to be defined in the studies called for by the "Plan & Schedule."
- O Adopts the New Castle Sanitation Authority's Wasteload Management Corrective Plan & Schedule as a revision to its Official Plan to be used to judge the acceptability of sewer connection proposals until ultimate compliance is reached.
