- a. <u>Application for a Variance</u>: the sum of two hundred dollars (\$200.00) plus the actual cost incurred for public notice of any hearing held and decision rendered in connection therewith, and the actual cost of any stenographic record made of such hearing and /or transcription thereof.
- b. <u>Application for s Special Exception</u>: the sum of two hundred and twenty five dollars(\$225.00) plus the actual cost incurred for public notice of any hearing held and decision rendered in connection therewith, and the actual cost of any transcription of the stenographic record made of such hearing.
- c. <u>Application for a Conditional Use</u>: the sum of one hundred dollars (\$100.00) plus the actual costs incurred for public notice of any hearing held and decision rendered in connection therewith, and the actual costs of any transcription of the stenographic record mad of each hearing.
