ORDINANCE NO. 3 of 2012

**AN ORDINANCE OF THE TOWNSHIP OF SHENANGO,
LAWRENCE COUNTY, PENNSYLVANIA, AUTHORIZING
THE TOWNSHIP TO PARTICIPATE IN AN
INTERGOVERNMENTAL AGREEMENT PROVIDING
FOR BOOKING OF ALL INDIVIDUALS CHARGED WITH
A CRIME AT A CENTRALIZED BOOKING CENTER.**

Section 1. This Ordinance is made and adopted by the Township of Shenango (the "Township") pursuant to the authority pursuant to the Pennsylvania Intergovernmental Cooperation Law, 53 Pa.C.S. §2301, et. seq.

Section 2. The Township, in order to protect the health, safety and welfare of its citizens hereby ordains and enacts this Intergovernmental Cooperation Agreement authorizing the Township to enter into an Intergovernmental Cooperation Agreement which includes the following municipalities as parties: Lawrence County, the City of New Castle, Borough of South New Castle, Township of Hickory, Township of Neshannock, Township of Scott, Township of Washington, Township of Slippery Rock, Borough Bessemer, Borough of S.N.P.J., Township of Mahoning, Township of North Beaver, Township of Taylor, Township of Union, Borough of New Wilmington, Borough of Volant, Township of Shenango, Township of Pulaski, Plain Grove Township and Township of Wilmington. The said Agreement shall be known as the "Central Booking Program Intergovernmental Agreement" (hereinafter referred to as the "Agreement").

The Chairman of the Board of Supervisors is hereby authorized to sign the Agreement on behalf of the Township, in accordance with Section 10 of the Agreement.

Section 3. The Agreement is appended to this Ordinance and the terms and conditions contained therein are incorporated into this Ordinance as if set forth in full.

Section 4. The term of the Agreement shall be five years commencing on the date of execution thereof.

Section 5. The purpose of the Agreement is to establish, fund and maintain a joint centralized program in Lawrence County, Pennsylvania to be utilized by the participating municipalities.


Section 6. The financial obligations for establishment and operation of the Central Booking program shall be paid by a booking center fund fee pursuant to 42 Pa.C.S.A. §1725.5 and assessed detainees by the Court.

Section 7. The Lawrence County Correctional Facility will provide program space, staffing and administrative oversight of the program.


Section 8. This Ordinance shall become effective five (5) days after enactment as provided by law.




