Motion by Andrew Piccuta second by Ronald Golba to pay general fund bills. Motion carried.

Motion by Andrew Piccuta second by Ronald Golba to pay sewer funds bills. Motion carried.

Motion by Andrew Piccuta second by Ronald Golba to grant requests for wage tax refunds. Motion carried.

Motion by Andrew Piccuta second by Ronald Golba to adopt Resolutions 5 through 13, 15 and 16 to exonerate properties from real estate taxes. Motion carried.

Motion by Andrew Piccuta second by Ronald Golba to adopt Resolution 17. This resolution allows the supervisors to enter into an agreement with Penn Power to furnish and install sodium vapor street lights. Motion carried.

Motion by Andrew Piccuta second by Joseph Shinsky to adopt Resolution 18, authorized official resolution. This resolution authorizes Ronald J. Golba to execute all documents for the Community Facilities Grant. Motion carried.

Motion by Andrew Piccuta second by Ronald Golba to appoint William Bintrim as the backup sewage enforcement for Clair Robinson. Motion carried.


