Motion by Joseph Budai second by Andrew Piccuta to adopt zoning amendment 1-1995: Zoning Text Change which would allow an Inn in an R-2 Residential Zone.

Motion by Joseph Budai second by Andrew Piccuta to adopt zoning amendment 2-1995: This amendment would consist of a zoning map change for parcel number 3909-330E, located at 2619 Old Butler Road and owned by Ranier Devido. The current zoning is R-1 the amendment would change the zoning to C-2.

Motion by Joseph Budai second by Andrew Piccuta to adopt zoning amendment 3-1995: This amendment would consist of a zoning map change for parcel number 3907-123, located on Basilone Drive and owned by William Basilone. The current zoning is C-2 and the amendment would change the zoning to R-1.

Motion by Joseph Budai second by Andrew Piccuta to approve one sewer credit to LCED.


Motion by Joseph Budai second by Andrew Piccuta to release the pension of Teresa K. Sparacino.
