Motion by Joseph Budai second by Richard Schweinsberg to approve the following sewer credits:


Steve Lysko Subdivision: 11 Credits

The following public comments were heard:

Larry Bintrim, R.D.#4: questioned on the procedure for allocating sewer credits. Supervisor Budai explained the previous moratorium for the treatment plant the procedure each township must now follow for growth and development.

Mr. Carl Sacherich questioned the board on how soon sewerlines would be extended to Hoover Road Extension. He was informed that a scheduled date had not been set but the lines would be extended within the next ten year period. Mr. Sacherich then questioned as to when the reorganizational meeting would be held. He was informed it would be held on January 3 , 1993 at 7:00 p.m. Mr. Sacherich then questioned the pump house formal meeting which was to be held by the auditors. He was informed that the supervisors had questioned the auditors on this matter and were told that no meeting would be held. Mr. Sacherich then questioned what was being done about the monies Golba owed for the pump house. He was informed that charges had been filed at the District Magistrates for these monies.
