The meeting was opened with a salute to the flag.

The minutes were read and approved from the previous meeting.

The Police Report was given by Chief Nocera.

Motion by Mrs. Wehr second by Mr. Albertini to approve payment of the general fund expenses.

Motion by Mrs. Wehr second by Mr. Albertini to approve the sales agreement for apportion of the property next to the municipal building to Timothy & Diane Kalajainen.

Motion by Mrs. Wehr second by Mr. Albertini to enter into a Sewage Service Agreement for Cambridge at Hidden Lake.

Public Comment:

Mr. Oran Allen, asked if something would be done about the water problems on Old Pittsburgh Road, culverts buried below the driveways. Mr. Allen also asked if the Township had a residency requirement.

Mr. William Alexander, stated that there are 28 cracks or breaks on Savannah Gardner Road.

Mr. Tim Weinschenk , asked if anything could be done with the bridge on Pennsylvania Avenue, or if narrow bridge signs could be put up. Mr Weinschenk also stated that there continues to be water and ice problems on Quarry Road.
Would the front footage assessment be imposed on the new condo development on Savannah Road.

Brenda Yakubik, presented a petition requesting a turning arrow for the North and South intersection of Rt. 388 and 422

Mr. Dean Jones, asked if an exemption or instruction on the proper installation of the 911 address signs.

Mr. Bob Hinton, stated Spring Hill Lane continues to have water and ice problems.

Mr. Ken Cannon, stated that there continues to be a problem with 4 wheelers in the park and Gardner Stop area.
