

REGULAR MONTHLY MEETING
September 10, 1992

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, September 10, 1992 at 7:00 p.m. at the Shenango Township Municipal Building, with supervisors Joseph Budai and Richard Schweinsberg present.

The meeting was opened with a salute to the flag.

Motion by Richard Schweinsberg second by Joseph Budai to approve the minutes from the August 13, 1992 meeting as read.

Motion by Richard Schweinsberg second by Joseph Budai to approve the general fund bills.

Motion by Richard Schweinsberg second by Joseph Budai to approve the sewer fund bills.

Motion by Richard Schweinsberg second by Joseph Budai to approve per capita/wage tax refunds.

Motion by Richard Schweinsberg second by Joseph Budai to approve the Hobrat subdivision.

Motion by Richard Schweinsberg second by Joseph Budai to approve the Robinson Development upon minor engineering revisions which are to be made.

Motion by Richard Schweinsberg second by Joseph Budai to adopt the emergency management plan. (Resolution 12-1992)

Motion by Richard Schweinsberg second by Joseph Budai to adopt Resolution 14-1992, this is an authorizing resolution to accept additional roads for winter maintenance from PENN DOT.

Motion by Richard Schweinsberg second by Joseph Budai to adopt Resolution 15-1992, this resolution states the line of succession for officers of the township.

Police Chief Anthony Decarbo gave the police report.

Motion by Richard Schweinsberg second by Joseph Budai to award the contract for the Hoover Road Waterline Extension project to ANNICO upon approval from DCA.

Motion by Richard Schweinsberg second by Joseph Budai to accept the agreement for consulting services between the Township and C & W Consulting Services for inspection services for the housing rehabilitation program.

Motion by Richard Schweinsberg second by Joseph Budai to accept the petition presented by residents opposing the stop sign on Harmony Baptist Road.

Motion by Richard Schweinsberg second by Joseph Budai to adopt agreement to sell fuel to the South New Castle Borough Fire Department.

Motion by Richard Schweinsberg second by Joseph Budai to appoint Nick Ventura as a full-time officer for one year probationary period.


Motion by Richard Schweinsberg second by Joseph Budai to approve the rezoning an area currently zoned R-3 to R-1. This area is located south of Frew Mill Road and east of the New Castle City line.

Motion by Richard Schweinsberg second by Joseph Budai to approve the rezoning of an area currently zoned I-P to R-3. This area is south of County Line Road, east of the City of New Castle and North of the Frew Mill Road.

Comments from residents included the following:

- (1) Residents requested that the brick for the pump house be placed for bid instead of being done by supervisor Golba.
- (2) Residents asked if they could have a full disclosure of the amounts which are owed by supervisor Golba and what has been paid back for the pump house.
- (3) Residents questioned why a stop sign was proposed on Harmony Baptist Road. They were informed by supervisor Schweinsberg that a person had requested a stop sign due to an accident which occurred. He then requested a study be done, the study showed that the area does not warrant a stop sign.
