The minutes were read and approved from the August 12, 1993 meeting.

Police Chief Anthony DeCarbo gave the police report.

Motion by Joseph Budai second by Richard Schweinsberg to award the Daugherty Road Construction Contract number 93-3 to Gennaro Paving.


The floor was then opened for public comment, the following comments were heard:

1. Jim Bintrim, 204 Hoover Road: Informed Chairman Schweinsberg that he should not have been escorted out of the last public meeting due to the fact that the township had no resolution in effect stating time period restrictions for comments. He also informed Chairman Schweinsberg that he was in violation of the Sunshine Law and charges have been filed. Mr. Bintrim then questioned why Chairman Schweinsberg was the only supervisor signing checks. Mr. Bintrim stated that it was not legal for this to be done and that you cannot have one person running the entire township. Supervisor Budai stated that he at times comes in on weekends to sign checks which have been approved at a public meeting.

2. Sue Pounds, Quarry Road: Questioned the board on the township maintaining Quarry Road and what needs to be done in order for this to be an ordained road of Shenango Township.

3. Mel Booher, 2817 Forrest Avenue: Asked on the status of the subdivision for the Wanda Burick property on Harmony Baptist Road. Chairman Schweinsberg stated that they would discuss this issue after the meeting.
