RESOLUTION OF THE BOARD OF SUPERVISORS OF SHENANGO TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA, PROVIDING STANDARDS FOR THE REGULATION OF INDUSTRIAL WASTE

WHEREAS, Shenango Township entered into a Service Agreement with the City of New Castle, and the New Castle Sanitation

Authority to provide for the transportation and treatment of sewage, including industrial waste, and

WHEREAS, Shenango Township adopted an Ordinance providing for the regulation of industrial waste and sanitary seawge, and prohibiting the discharge of certain wastes and sewage into the sewer system, and

WHEREAS, both the Service Agreement and the Ordinance provided that the regulation of industrial wastes and sanitary sewage by the Township shall be consistent with similar provisions of the City of New Castle, and the New Castle Sanitation Authority, and

WHEREAS, the Environmental Protection Agency mandated an industrial waste pre-treatment program, and

WHEREAS, the City of New Castle adopted an Ordinance amending and supplementing the codified ordinances of New Castle, Pennsylvania, Article 933, Sanitary Sewage Discharge and Service Charges to set forth uniform requirements for direct and indirect contributors into the wastewater collection and treatment system of the New Castle Sanitation Authority and to enable the Authority to comply with all applicable state and federal laws required by the Clean Water Act of 1977 and the General Pretreatment Regulations (40CFR, Part 403), and

WHEREAS, said city ordinance provides that it shall apply to the City of New Castle, the New Castle Sanitation Authority, and to persons who are, by contract or agreement with the Authority, Users of the Authority's publicly owned treatment works, and

WHEREAS, the Township of Shenango under agreement with the New Castle Sanitation Authority has users of the Authority's publicly owned treatment works, and

WHEREAS, the Township of Shenango wishes to adopt said requirements as its standards in connection with the usage, transportation and treatment of industrial waste and sanitary sewage.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Shenango, Lawrence County, Pennsylvania, that the provisions of Article 933 of the Codified Ordinances of the City of New Castle pertaining to sanitary sewage discharge and service charges are hereby adopted as the standards, rules and regulations of the Township of Shenango, Lawrence County, Pennsylvania, in connection with the usage, transportation and treatment of industrial waste and sanitary sewage.
