

Regular Monthly Meeting
July 12, 2018

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, July 12, 2018, at 6:05 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The meeting was called to order, and opened with a salute to the flag.

Mr. Augustine announced that the supervisors held an executive session regarding personnel and legal issues prior to the meeting tonight.

Public Comment:

Bill Cheslock, Old Princeton Road, spoke about the police patrolling state highways rather than township roads. Continued that township roads have speeding issues, and police should not be conducting DOT inspections of trucks, but rather focusing on speeding along with stop sign and traffic light enforcement.

Aaron Miller, spoke about the temporary repairs that are being performed by contractors of the sanitation and waterline extension project, and the effect it is having on travel in the township.

Marsha Presnar, Circle Drive, said that there were excessive fireworks on the 4th of July this year, which made it impossible to be outside, and could have caused a tree to fall over on her property nearly missing her husband while cutting grass.

Public Relations and Announcements:

Mr. Burick explained the upcoming Car Show and Movie Night at the park, and the Back 2 School movie at the park.

Mr. Burick explained the current status of the improvements taking place at the Shenango Township Community Park.

Mr. Burick spoke about the plan for paving in 2018, and which streets will be improved.
