## Regular Monthly Meeting May 10, 2018

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, May 10, 2018, at 6:10 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The meeting was called to order.

Mr. Augustine announced that the supervisors held an executive session regarding personnel and legal issues prior to the meeting tonight.

Mr. Augustine thanked Chief Rishel and the Fire Department for the escort given to the Shenango High School girls track team the night they won the WPIAL championship.

Public Comment:

Barb Thompson, Boyd School Road, congratulated Solicitor Lou Perrotta for a recent article in the New Castle News, then asked in the event there would be any hearings regarding the former YDC property, would the public be notified, then asked about the Sankey Hill trail. Solicitor Perrotta said it is all accessible to the public on the website of the Federal Court, but there has been nothing scheduled. Ms. Thompson asked about restitution regarding Brian Tanner and if anyone will be monitoring Brian Tanner after being released from jail. Solicitor Perrotta said he cannot make any comment on supervision, it is not within his purview, and said there is a pending civil suit with multiple defendants.

Mr. Burick explained the award of a \$920,000.00 grant to Shenango Township to improve Sankey Hill for the North Country Trail, which runs from Maine to North Dakota, at no cost to the Township. Mr. Rishel commended Mr. Burick for his work done in regards to obtaining the grant.

Marsha Presnar, Circle Drive, asked why residents have to put what they would like to speak about when they sign in. Solicitor Perrotta explained the reason.

Charles Johnson, Mosser Drive, said he was never given an occupancy permit from Richardson Inspection Services for his picnic shelter. Mr. Augustine said he would check into it.

Mr. Burick explained the Dirt and Gravel Road Grant Project of \$70,178.22, which will be to improve Chewton West Pittsburg Road.

Mr. Burick explained the \$920,000.00 Surface Transportation Block Grant Program which was awarded to Shenango Township.

Mr. Burick said they are looking to resurface the pickleball courts at Shenango Park and it is going to be exclusively pickleball.
