## **Special Meeting**

Proposed Amendment of Ordinance No. 1 of 2001 in respect to Provide Definitions and Conditions for the Sale and Storage of Fireworks and Permitting Such Uses in the C-2 Highway Commercial District by Conditional Use

May 10, 2018

A special meeting of the Shenango Township Board of Supervisors was held on Thursday, May 10, 2018, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The purpose of the meeting was for the Proposed Amendment of Ordinance No. 1 of 2001 to provide definitions and conditions for the sale and storage of fireworks and permitting such uses in the C-2 Highway Commercial District by conditional use.
