

Special Meeting  
Liquor License Transfer for Big Pauly's Sports Bar  
September 13, 2018

A special meeting of the Shenango Township Board of Supervisors was held on Thursday, September 13, 2018, at 5:30 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Brandon Rishel and Albert Burick, III, present.

The purpose of the meeting was to hear testimony for a Liquor License Transfer into Shenango Township from in safe keeping at 2525 Wilmington Road, New Castle, Pennsylvania 16105, License No. R-16654 for Big Pauly's Sports Bar for property located at Permanent I.D. 31-330600, 1403 Old Butler Road, New Castle, Pennsylvania 16101.

The meeting was called to order and opened with a salute to the flag.

Paul Lynch was sworn in at this time and explained the reason for his request for this transfer from Bella Cibo, LLC, owned by JennJess, LLC, to Big Pauly's Sports Bar.

There were no questions from the Board of Supervisors.

Solicitor Perrotta said there is a Resolution and the property was posted by the LCB and it is pending application.

There was no comment from the Board of Supervisors, and Solicitor Perrotta said the testimony is closed. Solicitor Perrotta said there was a favorable ruling on the Application for Nonconforming Use as a Special Exception after a hearing today at 5:00 p.m. before the Zoning Hearing Board.

Motion by Mr. Burick second by Mr. Rishel to approve the Inter-municipal Liquor License Transfer of Liquor License No. R-16654 into Shenango Township from Bella Cibo, LLC, 2525 Wilmington Road, Neshannock Township, owned by JennJess, LLC, to Big Pauly's Sports Bar located at 1403 Old Butler

Road, Shenango Township, Lawrence County, Pennsylvania. Roll call: Mr. Augustine, yes; Mr. Rishel, yes; Mr. Burick, yes. Motion carried.
