## Special Meeting Conditional Use Cemex Construction Materials Atlantic, LLC January 16, 2020

A special meeting of the Shenango Township Board of Supervisors was held on Thursday, January 16, 2020, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The purpose of the hearing was to consider the application for Conditional Use submitted by Cemex Construction Materials Atlantic, LLC, for the development of a 593-acre underground limestone mine near East/Northeast of the intersection of Conner School Road and Chewton West Pittsburg Road.

The hearing was called to order and opened with a salute to the flag.
