Public Comment:

Barbara Thompson, Boyd School Road, spoke about an experience she had in front of the Discovery House in Union Township and questioned the appeals process regarding the proposed Methadone clinic in Shenango Township. Solicitor Perrotta explained the procedure for the January 13, 2016, scheduled date for argument on legal briefs submitted in the case.

Shirley Sallmen, Old Princeton Road, spoke about trying to get Iron Mountain relocating to the former YDC building, and perhaps the Township could bid on the property and lease it to them. The supervisors said Iron Mountain is not interested in leasing, they want to build. Mr. Augustine said the supervisors had talked to Chris Sainato and he said another agency was moving into the YDC, but that fell through and so it was going to go up for bid again.

Bill Phillips, Highview Drive, presented the supervisors with Right-to-Know request forms, expressed his concerns with time cards he had received from a previous Right-to-Know request, and asked who calls out the road crew. Mr. Riley said nothing has changed, the police department still calls them out.
