

Regular Monthly Meeting
June 11, 2020

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, June 11, 2020, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine and Brandon Rishel present.

The meeting was called to order and opened with a salute to the flag.

Mr. Augustine announced that the supervisors held an executive session regarding legal zoning enforcements prior to the meeting tonight.

Also, there have been ATV crashes at the CEMEX property, and there is work being done to make it safer down there and having it properly posted, and the fire department is doing training there.

Solicitor Perrotta said there would need to be a registration ordinance and fees collected, and the fees escalate as time goes on.
