

Regular Monthly Meeting
May 14, 2020

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, May 14, 2020, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The meeting was called to order and opened with a salute to the flag.

Motion by Mr. Burick second by Mr. Rishel to approve the minutes of the Regular Monthly Meeting of April 16, 2020. Motion carried.

Staff Reports:

Fire Chief David Rishel gave the monthly Fire Department report.

Emergency Management Coordinator Justin Data said everything is back to business.

Public Comment:

Bill Cheslock, Old Princeton Road, said someone told him the supervisors turned down an offer from Rural King to come to the plaza. Mr. Burick said he himself reached out to Rural King, and the owner of the plaza is not interested in selling.

Philip Julian, Ellwood Road, spoke about gun activity behind his house and asked if the noise ordinance has ever been revisited. Solicitor Lou Perrotta said it has not. (Mr. Julian turned on his phone to let the supervisors hear the gun activity that he had recorded.) Mr. Augustine said the supervisors will check into it. Mr. Julian said he spoke to the police about the situation and they advised him they could not enforce the noise ordinance in such a situation.

Tom Baker, Harmony Baptist Road, asked if the supervisors are trying to stop hunting and shooting in the township. Mr. Augustine said there is no way they would do that, and they just want people to be good neighbors.

Solicitor Perrotta said it is legal to shoot if it is structured and the backstop is appropriate. Solicitor Perrotta said the police are correct that they cannot enforce the noise ordinance in such a situation, disorderly conduct may be the correct way to proceed, but it will be looked into.

Eric Buchanan, Hollow Road, had nothing further to add to what had already been said.
