### Discussion Items:

Mr. Augustine announced South New Castle Borough wants to become a part of Shenango Township and there was a discussion regarding a merger plan.

The supervisors discussed the township entering into discussion with Republic Services to extend the current contract with them for one year.

Motion by Mr. Rishel second by Mr. Burick to amend the agenda. Solicitor Lou Perrotta asked if there was any public comment, to which there was no response from anyone present. Motion carried.

Motion by Mr. Burick second by Mr. Rishel, as a result of the lack of interest in obtaining bid specs and the inability of one of the contractors to obtain the proper equipment along with the interruption on the supply chain as a result of the COVID-19 Pandemic, Shenango Township desires to extend its recycling and garbage contract for one year, with no price increase. Solicitor Perrotta asked if there was any public comment, to which there was no response from anyone present. Motion carried.

Mr. Rishel announced the current sewer and water project is about 75 percent complete at this time.

Shirley Sallmen, Old Princeton Road, asked if there was anything new with the plaza. Mr. Augustine said Chip Harrup, one of the owners, said he plans to obtain financing by the end of July to enable him to buy his partner out.

Bill Cheslock, Old Princeton Road, asked if the Township lost a patrolman, because he saw an ad in the newspaper. Mr. Rishel explained the current situation and the reason the ad was put in the paper was to update the list of applicants. Mr. Cheslock also asked about the signs on Old Princeton Road regarding fresh tar and chip. Mr. Rishel said the signs were put there because of the bleed through, and there would be no new tar and chip.
