## Regular Monthly Meeting June 10, 2021

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, June 10, 2021, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The meeting was called to order and opened with a salute to the flag.

Motion by Mr. Burick second by Mr. Augustine to approve the minutes of the Regular Monthly Meeting of May 13, 2021. Motion carried.

Staff Reports/Announcements:

Mr. Augustine explained Fire Chief David Rishel is out of town, but reported that there were 73 calls for the month for the Fire Department.

Sergeant Darrin Cwynar reported ATV and quad thefts are up, crashes are very high, and reminded residents to lock things up because people are stealing everything.

Mr. Burick explained "Heroes N' Kids Days" at the Shenango Community Park on two Fridays in July where, among other things, a member of the Police Department and the Fire Department will be reading to children at the park.

The supervisors congratulated the Shenango softball and baseball teams on their performance this year.

Public Comment:

Bill Cheslock, Old Princeton Road, complained about speeding on Old Princeton Road.

Dan Gallaugher, Wiley Lane, spoke about wanting to increase the size of the culvert pipe under Wiley Lane. Mr. Burick said the matter was discussed with the Public Works Department, and the supervisors need to talk to the State. Mr. Rishel asked Mr. Gallaugher to give him his information after the meeting and he would take a look at it.

Marsha Presnar, Circle Drive, asked how long she would have to wait before she can turn a neighbor in for barking and crying dogs. Mr. Rishel told her to call the non-emergency police number when it is happening. Ms. Presnar asked that a fence being erected by a neighbor be checked for its height.

Michelle Prestopine, Wiley Lane, asked how the sanitation will be connected at the new proposed development on Harmony Baptist Road. The supervisors advised Ms. Prestopine that there was a

Sewage Planning Module before them tonight and it is a preliminary planning module, and the supervisors have very little information at this time, but it will probably be at Harmony Baptist Road.

Charles Johnson, Mosser Drive, spoke about Ordinance No. 1 of 1956 and how he felt Mr. Burick was in violation of that ordinance. Solicitor Lou Perrotta said he is sure there is an ordinance or legislation that took care of that.

Motion by Mr. Rishel second by Mr. Burick to approve payment of the Payroll Fund expenses of \$88,728.98. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to approve payment of the Fire Tax Fund expenses of \$18,613.03. Motion carried.

Motion by Mr. Burick second by Mr. Rishel to approve the creation of an ARPA Fund Account at PLGIT for the purpose to deposit monies allocated by the federal government through the American Rescue Plan Act of 2021. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to approve the purchase of a 2021 Ford Police Interceptor from Bill McCandless Ford of Mercer, PA, through the Pennsylvania COSTARS Program at a cost of \$34,041.00. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to approve the upfitting of a 2021 Ford Police Interceptor to be performed by Ibis Tec of Saxonburg, PA, at a cost of \$12,978.00. Motion carried.

Solicitor Perrotta explained amending the Zoning Ordinance and explained that it changes areas, not the process, and it was last done in 2001.

Motion by Mr. Burick second by Mr. Rishel to authorize advertisement of the Pending Draft Ordinance for a zoning amendment. Motion carried.

Motion by Mr. Burick second by Mr. Rishel to approve the Sewage Facilities Planning Module for the proposed 66-unit condominium development "The Fields at Forest Run" to be located near the intersection of Harmony Baptist Road and Wiley Lane. Motion carried.

Motion by Mr. Burick second by Mr. Rishel to approve Resolution #10 of 2021 – NCATA Match Agreement. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to adjourn.
