

Regular Monthly Meeting
September 9, 2021

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, September 9, 2021, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present.

The meeting was called to order and opened with a salute to the flag.

Mr. Augustine announced that previous to the meeting the Board of Supervisors had an executive session for personnel.

Motion by Mr. Rishel second by Mr. Burick to approve the minutes of the Special Meeting – Bid Opening on August 24, 2021. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to approve the minutes of the Regular Monthly Meeting of August 12, 2021. Mr. Augustine abstained. Motion carried.

Staff Reports/Announcements:

Mr. Justin Data spoke on behalf of Fire Chief David Rishel and reported that there were 56 calls for the month for the Fire Department and said that Covid-19 calls are beginning to pick up again.

Motion by Mr. Rishel second by Mr. Burick to approve the advertisement for the position of Clerical Assistant. Motion carried.
