Lawrence Village Plaza

Kmart lease will end in February. 2020-2021 taxes were not paid in the lease. Several attempts were made to the current owners to help improve the plaza, such as you invest x amount, and we'll invest x amount, but nothing has progressed. Looking into legal options and possible conservatorship.

Police Body Cams

Darrin spoke about the necessity of body cams for the department not only for the safety of the officers and community but also to stay modern with technology. Mr. Rishel discussed options of purchasing the best quality body cams along with taking the most cost saving measures.

Traffic signals updates

\$3,850.00 for the installation of 36" solar powered curve ahead (W1-2R) sign mounted on a 4x6 wood post along Rt. 65 North near the old Hill View Manor. 14 issues with impaired or distracted drivers within the last 3 years at Dollar General/Dairy Queen properties being damaged due to accidents. The state did replace "turn ahead" signs.

\$1,050.00 each or \$5250.00 total for the installation of generator adaptor kits to the traffic signal cabinets oat the following intersections: 65 & Shenango Plaza, 65 & Old Princeton Road, 65 & 422 EB/WB ramps, 422 & Giant Eagle Plaza, and 422 & 388.

\$4,000.00 each or 8,000.00 total for installation of (2) 48" solar powered signal ahead (W3-3) signs on 4x6 wood posts in advance of the SR 422 and SR 388 intersection along 422 EB and WB directions. Signs will be placed 2,000 ft out from the light. Slippery Rock Township will also be purchasing one for their side of the intersection.
