RESOLUTION NO. 17 OF 2021**

**A RESOLUTION OF THE TOWNSHIP OF SHENANGO,
COUNTY OF LAWRENCE, COMMONWEALTH OF PENNSYLVANIA,
APPROVING THE TRANSFER OF A RESTAURANT LIQUOR LICENSE (NO. R-14407) INTO THE
TOWNSHIP OF SHENANGO**

WHEREAS, Act 141 of 2000 ("the Act") authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in the Township of Shenango, sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the liquor license prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant's intent to transfer a liquor license into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality; and

WHEREAS, a hearing was conducted on the 10th day of November, 2021 at 5:30 P.M. at the Shenango Township Municipal Building, 1000 Willowbrook Road, New Castle, PA 16101.

NOW, THEREFORE, BE IT RESOLVED, that Tim Toc, LLC, having a corporate address of 547 Mt. Jackson Road, New Castle, PA 16102, has requested the approval of the Township of Shenango Board of Supervisors for the proposed transfer of Pennsylvania restaurant liquor license no. R-14407 from the Pennsylvania Liquor Control Board to a facility within the Township of Shenango to be located at 2655 Ellwood Road, New Castle, PA 16101, with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Township of Shenango Board of Supervisors has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; and

BE IT FURTHER RESOLVED, that the Township of Shenango Board of Supervisors approves, by adoption of this resolution, the proposed inter-municipal transfer of restaurant liquor license no. R-14407 into the Township of Shenango by Tim Toc, LLC for utilization at 2655 Ellwood Road, New Castle, PA 16101; and


BE IT FURTHER RESOLVED, that transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.
