March 10, 2022

The meeting was called to order and opened with a salute to the flag.

Mr. Rishel brought up a new pre-incident form on the fire department's website for residents and businesses to fill out about their building's construction, occupancy, layout, potential hazards, and fire protection systems. This form will only be used by fire department personnel to help make decisions when an emergency arises. The more pre-incident plans that the fire department has on file the better their ISO rating is likely to be for insurance and other important reasons.
