Regular Monthly Meeting May 13, 2021

The meeting was called to order and opened with a salute to the flag.

Staff Reports/Announcements:

The Shenango Township Supervisors, along with the County Commissioners and Slippery Rock Township Supervisors, are going to be asking PennDOT to look into more safety precautions at the intersection of Routes 422 and 388, due to the number of accidents that have occurred at that intersection.

Fire Chief David Rishel gave the monthly Fire Department report, 68 calls for the month and a total of 255 calls so far this year. Chief Rishel said people have really stepped up the last two months and helped saved lives.
