Fire Chief David Rishel reported that there were 63 Fire/EMS calls for the month and 514 call so far for the year.

PA Skill Games presented the SAFD with a \$3,000 check from a grant that was applied for by the fire department.

Public Comment:

Bill Cheslock praised our public works crew for keeping the grass cut along the highways. Everyone agreed by keeping the grass maintained that it would make our township stand out from other areas that may not keep theirs as nice.

Shirley Sallmen expressed her concerns about the Lawrence County Economic Development Corporation having behind closed-door meetings and that townships are not allowed representation at these meetings. There's no accountability.

Judy Martwinski asked about the pink flags in the yard of some residences. They are for a Columbia Gas 2023 summer project.

Tom Mackin was upset that his subdivision was denied and asked the supervisors what he needed to do to get it approved. The supervisors gave Mr. Mackin information in regard to what they had asked for previously from the engineers and that the property is known to hold water.
