It is very helpful to have someone at the station to be constantly checking the equipment and making sure it's available for the next call. Many positive things have been said about our response times since we've initiated this process.

Judy Martwinski spoke about the need for a traffic mirror on Big Run Creek Road. Mr. Rishel is looking into it.

Brandon told Dan Gallaugher that his project on Wiley Lane has been approved for Spring. Dan Gallaugher also mentioned about increasing police presence on 388/422 and Harmony Baptist Road to slow people down from speeding.

Discussion Items:

The adoption of a Property Maintenance Code was discussed at this time.

LD Ferraro Properties- Ms. Ferraro is wanting to donate some property she still owns within the township that is of no use to her. This property is located on Polk St. off of Alveretta Blvd and is a paper street. The property is wooded and may not be able to be developed. More questions are needed before we'd be able to take on these properties.

2022 Summer Road Resurfacing Project- Need to select which roads we are going to take on this year.

Sustainable PA Certification- We are in the process of applying for this certification so that we can make the township more sustainable and hopefully get grant money to help fund different projects.
