The meeting was called to order and opened with a salute to the flag.

Motion by Mr. Burick second by Mr. Rishel to approve the minutes of the Regular Monthly Meeting of May 12, 2022. Motion carried.

Staff Reports/Announcements:

Fire Chief David Rishel reported that there were 76 calls for the month for the Fire Department. 54 EMS and 22 fire related. New ATV for emergencies will go into service soon. It was donated by 2 individuals who would like to remain anonymous. Emergency personnel will be trained before being allowed to operate the ATV.

Sergeant Darrin Cwynar reported that a traffic enforcement grant will allow them to increase their presence. Also, to keep vehicles locked and an eye on each other.

Motion by Mr. Burick second by Mr. Augustine to approve the purchase of a 4,000 series Z-Master by Toro zero turn mower from Four Ways Sales and Service at a cost of \$11,538.38. Motion carried.

Motion by Mr. Rishel second by Mr. Burick to approve the purchase of a Brush hog attachment from North East Attachment & Track at a cost of \$6,280 and tracks from Bobcat for \$4,995.00. Motion carried.
