

Regular Monthly Meeting  
May 12, 2022

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, May 12, 2022, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present. Also present was solicitor Louis Perrotta.

Mr. Augustine announced that the supervisors held an executive session regarding personnel prior to the meeting today.

The meeting was called to order and opened with a salute to the flag.

Staff Reports/Announcements:

Fire Chief David Rishel gave the monthly Fire Department report, 63 calls for the month (20 fire related and 43 EMS calls) and a total of 251 calls so far this year.

Envirothon- Teams from high schools in Lawrence County competed in a fun, competitive, academic event on May 3, 2022, at Shenango Township Community Park. Envirothon is designed to educate high school students in natural resource and environmental sciences. It combines in-class curriculum and outdoor training to help high school students learn more about aquatic ecology, forestry, soil & land use, wildlife, and current environmental issues.
