422 & 388- On April 29, 2022, a Full Safety Assessment was submitted to Penndot. Penndot responded back on December 1, 2022, with a denial of any changes needed to the intersection.

HOME Grant- Governor Wolf announced more than 10.3 million in new funding with \$500,000 going to our township for existing owner-occupied housing in partnership with Lawrence County Community Action Partnership.
