

**Regular Monthly Meeting
August 10, 2023**

The regular monthly meeting of the Shenango Township Board of Supervisors was held on Thursday, August 10, 2023, at 6:00 p.m. at the Shenango Township Municipal Building, with Supervisors Frank Augustine, Albert Burick, III, and Brandon Rishel present. Also present was Township Solicitor, Lou Perrotta.

The meeting was called to order and opened with a salute to the flag.

Staff Reports/Announcements:

Fire Chief Dave Rishel announced they had 74 calls for the month and 468 calls for the year.

Justin Data (EMA) announced that all paperwork for the storm damage has been submitted. The Snake Run Bridge is down to one lane (6 Ton) until the bridge can be repaired or replaced. Over \$700,000 worth of damage occurred because of the storm on July 9, 2023.

Bob Milnes (Public Works) announced what roads will see paving (Links, Karon, and Pleasantview), liquid road (Williams, Wiley, Center, Hill, Orchard), and tar and chip (Graham, Roy, Willowhurst, Ruth, Old Butler, Hoover, Stewart, Hazen, Gibson, Sankey Hill, Douglas, Hollow, Station, Rose Stop, and Boyd School). Ridgewood Court is delayed until the project is completed on Savannah Road.

Fall Craft Market will be held on Saturday, September 9th from 10am-4pm at the Shenango Community Park. There will be 40+ vendors, food trucks, and live entertainment.

Movie in the Park will be held on Saturday, October 14th at 7:00PM at the Shenango Community Park. We will be showing the original Hocus Pocus and having free popcorn.

The park has had a variety of events this past year and we're hoping to continue to grow it. We held the Read and Learn program during the month of July, the Conservation District moved their nature camp from Ewing Park to our park, and the Pickleball Association has close to 200 members that come to our park daily.
