Shenango Township is seeking sealed bids for playground equipment at the Shenango Community Park, located at 238 Kittery Ridge Drive, New Castle, PA 16101

All bids will be publicly opened and read on April 11, 2024 at 10:15 a.m. at the Shenango Township Municipal Complex, 1000 Willowbrook Road, New Castle, PA 16101. Bids will be awarded at the Board of Supervisors Meeting, April 11, 2024 which begins at 6:00 p.m. or subsequent meeting as determined to be in the best interest of Shenango Township.

Project Description & Specifications

The bid submitted must include the cost of two playground structures.

Subject to compliance with requirements, provide the below products

One Playground structure for ages 2-5 (ADA, ASTM & CPSC Certified) with the capacity of 25 or more children, including the following items:

- At least two access/entrance items (i.e.: steps, ramp, steel or rope ladders, climbers, etc.)
 - A total of at least two slides connected to the structure.
 - No tube slides shall be included.
 - No “bumpy slides” shall be included.
 - Linking Components, ramps.
 - No crawl tubes, tunnels or track rides type elements shall be included.
 - Panels and ground level play component elements.
 - The space under platforms and decks are places for children to congregate and interact. The roofs provided by this create an enclosed space, and add to its appeal as gathering space.
 - One ground level play element shall address socialization and imaginative play (such as a playhouse or dramatic play area).

One Playground structure for ages 5-12 (ADA, ASTM & CPSC Certified) with the capacity of 90 or more children, including the following items:

- At least seven access/entrance items (i.e.: steps, ramp, steel or rope ladders, climbers, etc.)
 - A total of at least five (5) slides connected to the structure.
 - At least two (2) tube slides shall be included.
 - At least one (1) “bumpy slides” shall be included.
 - Linking Components, ramps.
 - No crawl tubes, tunnels or track rides type elements shall be included.
 - Panels and ground level play component elements.
 - The space under platforms and decks are places for children to congregate and interact. The roofs provided by this create an enclosed space, and add to its appeal as gathering space.
 - One (1) ground level play element shall address socialization and imaginative play (such as a playhouse or dramatic play area).

Three (3), Two bay swings accommodating children from 2-12 years of age.

- 2 bays of belt swings (4 total)
- 1 bay of full bucket swings (2 total)

One (1) stand alone spinning play event (ASTM, IPEMA & CPSC Certified) with the capacity of up to 2 children.

One (1) 4-way crawl tube play element. (ASTM & CPSC Certified)

One (1) 3 sided rope climber play element (ASTM, IPEMA & CPSC Certified)

All Playground Equipment must meet the following standards, with appropriate documentation provided:

- ASTM 1487: Standard Consumer Safety Performance Specification for Playground Equipment for Public Use.
- CPSC: Consumer Product Safety Commission for Public Playground Safety
- ADA: Americans with Disability Act

General Requirements:

- All submissions shall contain drawings and layouts, pictures, and complete specifications of the play equipment. Bids shall also contain any and all materials utilized.
- All fasteners shall be corrosive resistant
- Copy of all warranties shall be provided. Warranties shall cover a minimum of:
 - Powder Coating shall contain a minimum of a five-year warranty against fading when facing normal exposure. Testing in compliance with ASTM D 2244 shall be included within packet.
 - Lifetime warranty on steel posts.
 - 15-year warranty of pipes, steps, loops, rails, roto-molded plastics, HDPE plastic sheeting, steel platforms.
 - 5-year warranty on site amenities, cables and nets.
